

BISHOP LAWI IMATHIU SECONDARY SCHOOL: FACILITY DEVELOPMENT, SCHOLARSHIPS AND OTHER GRANTS.

Bishop Lawi Imathiu Secondary School (BLISS) is a day public school that serves the poorest families in the community that cannot afford the predominant boarding school system in Kenya. Current enrollment exceeds 700. BLISS is considered a high performing school, based on student performance on their National Exam. 2019 support progress included:

BLISS HALL: \$35,991

Construction continued on Multi-Purpose Building to provide large gathering space (up to 1,000) to host whole-school events, student dining during rainy seasons, interschool events and competitions, teacher-parent meetings, music practices and performances, and community gatherings.

Solar Water Pump: \$5,198

A solar water pump was installed on the school well to eliminate the prohibitively expensive cost of electricity. The water will be used as a potable water supply for human consumption, sanitation and irrigation needs at the four adjacent schools.

Green House Renovation: \$3,448

The Green House at BLISS was restored from major storm damage and will be used to provide vegetables and cash crops to support student school meals to ensure proper student nutrition for a healthy and nurturing learning environment.
