

Partner with local Kenyan communities to educate children and youth living in acute poverty and overcoming barriers to education.

Key partners include school and community leaders, secondary schools, primary schools, children's home, and community cultural center.

BISHOP LAWI IMATHIU SECONDARY SCHOOL: FACILITY DEVELOPMENT, SCHOLARSHIPS AND GRANTS.

Bishop Lawi Imathiu Secondary School (BLISS) is a day public school that serves the poorest families in the community that cannot afford the predominant boarding school system in Kenya. Current enrollment exceeds 700. BLISS is considered a high performing school, based on student performance on their National Exam. 2020 progress included:

BLISS HALL: \$25,143

Construction continued on Multi-Purpose Building to provide large gathering space (up to 1,000) to host whole-school events, student dining during rainy seasons, inter-school events and competitions, teacher- parent meetings, music practices and performances, and community gatherings.

Public Health Initiative: \$19,306

The Public Health Initiatives to address sanitation, begun in 2017, were completed in 2020. The finished BLISS washrooms provide gender-sensitive sanitation facilities, hygiene promotion with hand washing and a sense of security. Both boys and girls now have access to a quality sanitary environment for improved health.

Water Tank Restoration: \$1,888

The school's main water tank was replaced after the existing one collapsed from an earth tremor. The water is used as a potable water supply for human consumption, sanitation and irrigation needs at four adjacent schools.

SCHOLARSHIP GRANTS (\$11,426) Granted scholarships for over 100 disadvantaged youth to attend BLISS. Granted 10 university academic scholarships for top-performing BLISS graduates (including both top performing male and female each year).

TEACHER SUPPORT GRANT (\$6,924) Provided supplemental support to BLISS teachers and staff to enable remote learning to the school year interrupted by the COVID-19 pandemic.

REVISION BOOKS (\$3,085) Provided revision books to prepare Form IV students for the National Exam.

SCHOOL SUPPLY GRANT (\$450) Provided supplemental school supplies related to the pandemic.

MAJOR PROGRAM GRANTS not related to facility development (TOTAL: \$21,885)

GRAND TOTAL BLISS GRANTS: \$68,223
