

BLISS has outgrown its facilities of 8 classrooms and 2 science labs. To meet increased educational demand and to provide space for supporting services, a second 8-classroom building was completed in 2014. Current enrollment exceeds 500.

Almost 600 students have graduated from BLISS since its first graduating class in 2007. In 2014, 40 out of 98 graduates qualified for university education. BLISS is making a tremendous impact in this rural community where youth had little hope or future just a few years ago. Grants: \$39,998.
