**SCHOOL CONSTRUCTION GRANTS**

Bishop Lawi Imathiu Secondary School (BLISS) is a day public school that serves the poorest families in the community that can not afford the predominant boarding school system in Kenya. BLISS has outgrown its facilities of 8 classrooms and 2 science labs. To meet increased educational demand and to provide space for supporting services, a second 8-room classroom building is under construction. This partially-finished building enabled a third section of first-year students to be added in January 2013. Current enrollment has reached 480 and will grow to 600 as the building is completed. Most students are the first in their family to attend and graduate from secondary school. Almost 500 students have graduated from BLISS since its first graduating class in 2007. In 2013, 41 out of the 91 graduates qualified for university education. BLISS garnered national attention in Kenya and was ranked a top secondary school indicating the high caliber of education provided. BLISS is making a tremendous impact in this rural community where youth had little hope or future just a few years ago.

**CHILDREN'S HOME GRANTS**

Kithoka Amani Children's Home (Meru, Kenya): Grants were made for (1) education and child development programs of abandoned, abused and orphaned children primarily due to impact of HIV/AIDS and other diseases; and (2) facility development to expand and improve housing and to meet government regulations. KACH serves the most vulnerable population and poorest members of the community. KACH is currently home to 31 children and provides support to numerous others that are placed with extended family members or at boarding schools. Education is the cornerstone value for child development at KACH, in addition to instilling values of strong work ethic and self-improvement. Children are set upon the path to become educated and grow into contributing members of the community.

Grants outside the US are managed by disbursing funds through a 3-person panel, composed of independent, well-respected community leaders.

Disbursements require 2 out of the 3 signatures and are made only after written authorization is provided by the Treasurer. Audits of the bank account are made twice each year by the Treasurer. Site visits of grant recipients are made by Board members or designated individuals 2 times per year, typically during a service work project. Progress is assessed at that time.

A student's progress is assessed at that time and determination made if it is satisfactory. Scholarship recipients are visited by a Board member or delegate, typically once per year during a service work project.
