

Partner with local Kenyan communities to educate children and youth living in acute poverty and overcoming barriers to education. Key partners include school and community leaders, secondary schools, primary schools, children's home, and community cultural center.

BISHOP LAWI IMATHIU SECONDARY SCHOOL: FACILITY DEVELOPMENT, SCHOLARSHIPS AND GRANTS.

Bishop Lawi Imathiu Secondary School (BLISS) is a day public school that serves the poorest families in the community that cannot afford the predominant boarding school system in Kenya. Current enrollment exceeds 700. BLISS is considered a high performing school, based on student performance on their National Exam. 2021 progress included:

BLISS HALL (Multi-Year Project Completed): \$15,598

Construction completed on Multi-Purpose Building to provide large gathering space (up to 1,000) to host whole-school events, student dining during rainy seasons, interschool events and competitions, teacher-parent meetings, music practices and performances, and community gatherings.

BLISS CHAIRS PROJECT: \$23,791

A priority need was identified for chairs in classrooms, science labs and the new 1,000-seat capacity BLISS Hall. Eight hundred chairs and 100 lab stools were purchased.

FACILITY DEVELOPMENT GRANTS (TOTAL: \$39,389)

COVID SCHOOL CHALLENGES GRANT: \$16,758

Due to COVID, it was compulsory in 2021 and 2022 for schools to incorporate an additional term. Shortened from 14 to 10 weeks, terms still had to cover the same syllabus. To effectively cover the required curriculum, BLISS lengthened daily classes to 6pm, and added Saturday and Sunday afternoon classes. Provided supplemental support to BLISS teachers and staff. Additional learning resources, revision books, school meals and supplies, and pandemic supplies were also required.

Tenth-Year Program Anniversary (2011-2021): Over 75,600 Sanitary Pads (made in Africa), and Over 12,000 Pairs of Girl's Underwear provided, and Girls' Restroom facility funded at BLISS. Removed barriers to education for young women in rural Kenya. The program supports female students by creating girl-friendly school environments by providing sanitary pads, underwear, tuition support, female health education, and adequate toilets. The program currently supports over 750 female students at 5 schools in Kithoka, a small village in Meru, Kenya.

Tenth-Year Anniversary 2011-2021: **OVER ONE MILLION CUPS OF PORRIDGE SERVED.** Provides morning porridge for students at Gichunge Primary and Kithoka Primary Schools. 2021 saw school gardens, tended by parents and community members, doing exceptionally well. Schools harvested notable crops of maize and beans to feed students. Plantings were completed for the 2022 season. KUEF grants supplemented the school farms' harvests. Teachers recognize improved attendance, children no longer falling asleep or fainting from hunger, and increased student participation.
